4. Matters Arising

RBS were written on 12th March re problems with Mobile Service. The letter was circulated to Members at the time but no response has been forthcoming from RBS. A Working Group has been set up by Dufftown Community Association to progress consultation with Dorenell Windfarm Community Fund

Tininver Park have received Grant funding from Tesco Bags Scheme

Hugh advised that, hopefully, problems re extractor fan at Fleming Hall was nearly at an end. The Gents Toilets at the Cabrach have been damaged. The insurance claim monies are in and Council workmen are awaited to carry out repairs before the facility can re-open.

Recent Press Reports suggest delays in launching LEADER due to IT problems with the new system

Cllr Paul advised problems with Water Rate Exemption for The Cottage. It had not been appreciated that Application for Exemption had to be made annually before 31st March The Cottage has received funding to purchase a Paper Binder and Guillotine

Rothes Council are seeking views on extending the Speyside Way from Craigellachie to Rothes. The Meeting thought this could bring economic benefits to Rothes. Hugh suggested that Speyside Visitor Centre could be of help by taking Opinion Forms which were to be circulated to obtain the views of the public.

The lack of Broadband in the Cabrach was raised. Hugh advised about a satellite based Broadband used in Shetland but this was considered too expensive
